

That on and after the first day of May, 1919, any person engaged in the business of leasing or licensing for exhibition positive motion-picture films containing pictures ready for projection shall pay monthly an excise tax in respect to carrying on such business equal to five per centum of the total rentals earned from each such lease or license during the preceding month. If a person owning such a film exhibits it for profit he shall pay a tax equivalent to five per centum of the fair rental or license value of such film at the time and place where and for the period during which exhibited. Article 1. Use of terms. - In these regulations, for convenience, unless obviously inapplicable, the term Film shall be held to mean positive motion-picture films containing pictures ready for projection; Person shall include partnerships, corporations, and associations, as well as individuals; Lease shall include license, and any method of letting and acquiring the use of a film for exhibition, for which a charge is made; Lessor shall include licensor, and any person granting to another the right to the use for exhibition of a film for profit; Distributor shall be synonymous with lessor or licensor; Exhibitor shall be synonymous with lessee or licensee ; and Rental value shall include license value. Art. 2. Effective date. - The tax is effective May 1, 1919, and attaches to sums accruing on...
